## **Meeting Opening:**

Susan M., Chairperson Panel 73, opened the meeting with the Serenity Prayer and a reading from As Bill Sees It.

### **Roll Call:**

Dan B., Secretary, conducted roll call. All six officer were present and 43 Districts represented, for a total of 49 out of 54 eligible voting members. Please see the roll call tally attached at the end for details.

## **Procedural Motion:**

The Chairperson then called for a motion to suspend the rules so Past Delegates could speak. The motion was made, seconded, and then passed without opposition.

## **Inspirational Comments from Past Delegates** Each was given 2 minutes – highlights:

- Marty S. (Panel 51): Please make sure your opinion isn't treated as gospel; read Dec 11<sup>th</sup>'s Daily Reflection, since it is particularly relevant.
- Lowell L. (Panel 59): Research, ask questions, have fun, enjoy the journey. Call the past Delegates.
- Sheilia D. (Panel 57): You are the guardians of AA in Eastern Pennsylvania; it's a responsibility to bring the group conscience to this august body. Remember that you run the Area; the officers are here to facilitate.
- Hugh H. (Panel 61): When deciding any issue, keep in mind how it will help the alcoholic who has yet to get sober. Reiterated to call Past Delegates for their experience and help have not been consulted much in recent years.
- Pat F. (Panel 65): Fasten your seatbelts, you're in for the ride of your lives. Please call the Past Delegates, who love getting calls. Get a service sponsor. Learn to use your voice it can help to write thoughts down in advance.
- Paul M. (Panel 69): You are here to focus on policy. Don't be afraid to come to the mic. You are responsible to all groups; visit other Districts to learn. Enjoy the journey.
- Debbie T. (Panel 55, Area 44): Remember we're here to help those who have not yet reached us. Just as Delegates think of what's best for ALL of AA, not just locally as DCMs, also think of what's best for all of Area 59.
- Daren F. (Panel 69, Area 29): You're the cheerleader for general service; how you report on events is important. A59 DCMs have comparatively more responsibility; you must read emails and pass on info to do your job.
- Marcia G. (Panel 41) could not be there in person, but Shelia D. read her poem, titled "Ode to Panel 73" (exceprt):
- "Now here's a word on Robert's Rules. Remember that you're not in school. To reach a decision, does not need precision. In AA, they're merely our tools."

## **Officer Reports:**

- Noted she serves as Area Registrar, will soon have access GSO's database of all groups, Fellowship Connection.
- DCMs will be given read-only access; until then, can provide reports upon request.

## TREASURER, TARA L.

- Tara stated general treasurer duties: financial reports; contributions, expenses, bank accounts, taxes, etc.
- She has already had training, processed expense reports, contributions, and signed a contract.
- She will send out group contribution summaries, and continue providing detailed P&L.

## SECRETARY, DAN B.

- Dan noted it was important to email District minutes to Area officers and the Archivist we do read them!
- He also discussed the Area roster, and the various new ways to obtain it, and choice of frequency.
- Submit DCM reports quarterly before the meeting using the form on the Area website; also form for Area library.
- Please use the Area calendar form on the website to submit events, keeping in mind anonymity.

#### CHAIRPERSON, SUSAN M.

- Susan listed the Chairperson responsibilities, including: Chairs Area events, assists DCMs with facilities, prepares agenda for quarterly meetings and Area events, maintains grid of District hosting history.
- Service calendar was sent out, lists important Area events along with expected attendance.
- Service calendar was created with the goal of having Districts host which have not recently; will send letters to those asked to host events soon.

## ALTERNATE DELEGATE, CURT C.

- Main duty is to assist the Delegate.
- Share-a-Day requires new location and search is active.
- DCM orientation is upcoming and important to attend both to learn about being an effective DCM as well as plan for the Delegate Mini Assemblies.
- Subcommittee Chair orientation will be held to assist chairs, and share knowledge on resources available.

#### DELEGATE, PETE B.

- Pete welcomed the DCMs, stressing the responsibility and how AA's future truly depends on them.
- The Delegate provided information about the 73<sup>rd</sup> GSC:
  - ☐ He is assigned to Literature (difficult and exciting); background info is expected around February 15<sup>th</sup>.
  - □ Pre-Conference Sharing (PCCS) is later than usual (April 15<sup>th</sup>), so more time for members to absorb material.
  - Please attend PCCS, so the Delegate can get a better sense of the Area group conscience!
  - Deadline for 2024 agenda items is September 15<sup>th</sup>.
- New mailing address for contributions to General Service Board / GSO.
- Pete also noted some General Service "tidbits" provided by our NE Regional Trustee:
  - □ Podcast on General Service; results forthcoming on 2022 Group member survey; publication backlog smaller.
- NERAASA
  - ☐ Tremendous opportunity to gain a wider perspective on issues affecting AA as a while and General Service.
  - □ 2023 Hotel is filled, but overflow available.
  - □ NERAASA 2024, planning meeting is in January 11, so please help.
- The Delegate went on to talk about the Area 59 subcommittee system:
  - We mirror conference as much as possible.
  - □ Purpose is to bring work to be studied in detail vs. "going it alone".

- Subcommittee assignments may possibly be changed if truly necessary, but ability for changes limited.
- □ Looking for ADCMs for Ad Hoc Digital Comms; please provide names by December 21<sup>st</sup>.
- Utilize the Area 59 website, <u>area59aa.org</u> it is a wonderful resource, filled with information!
- Pete then explained what to do during the break for lunch at various subcommittee tables:
  - Elect a secretary, pick next meeting date, and then report on it after the break.
  - ☑ You have Delegate recommendations, but there will be no time to go through them today.
- Finally, the Delegate expounded upon his overall vision for Panel 73, and offered general suggestions:
  - Pete exhorted the DCMs to read the section in the AA Service Manual about Leadership in Concept IX particularly *vision*. He then processed to read out loud a definition of *vision* from the manual.
  - □ Consider ideas for improvement; ideally at least one could come from every District.

  - We are not here to do Intergroup work. Rather, let's build policy for the future of AA.
  - □ Think forward and outward; widen they circle of recovery how can we expand the circle around those not here, and what can we do to help more people identify? Consider when reviewing recommendations.
  - ☐ Ask questions about how we will get our message to people 10 or 20 years from now.
  - ☐ These may be difficult questions, but if we don't ask them, we are under-utilizing of our service structure.
- Prior to a 10 minute recess, Pete stated the names of each subcommittee and the chairperson.

## **New Business:**

## CHAIRPERSON ACTIONS (HOW WE CONDUCT BUSINESS FOR THE PANEL).

• Susan read the list of Chairperson Actions for Panel 73:

- ☐ That the Area 59 committee and all of its subcommittees adopt and follow the parliamentary process following the General Service Conference, to deliberate and reach our Area 59 group conscience.
- □ That the Area 59 Committee respect the obligations of our landlord agreements, especially when smoking, only in legally authorized areas, away from public entrances and outside of all Area venues.
- □ That the Area Committee define a quorum for conducting substantial business, be 27 of the 54 eligible voting members. Committee members must be present to vote at the time the vote is called for. Once the chair recognizes that a quorum is not present during deliberations, he or she may suspend the process and schedule the business to a different time.
- □ That all proposals and subcommittee recommendations be submitted in writing in time for the Pre-Area officers meeting, so that final versions can be placed on the agenda ahead of the quarterly meetings. The chair has the right of decision to call for a motion to refer all proposed structure changes to the Structure Subcommittee for research and recommendations to the full Area Committee
- The Chairperson called for a motion to affirm the actions:
  - ☐ The DCM from District 24 so raised a motion, which was seconded by the District 30 DCM.
  - ☐ There was no discussion, and the Area Committee voted unanimously in favor.

## **DELEGATE ACTIONS (VOLUNTEER SERVANT AFFIRMATIONS)**

- The Delegate made a motion for a slate of candidates to be special servants in Panel 73:
  - Archivist, Donald H. | Assistant Archivist, Jack C.
  - □ Technology Servant, Fred S. | Assistant Tech Servant, Nick P.

  - □ Bridging The Gap (BTG) Coordinator, Jim L.
- The motion was seconded by the District 36 DCM; the Area voted in favor with none opposed.

## Delegate General Recommendations for Panel 73 (Motions for Continued Operation of Area Committee)

- The Delegate explained how there were operational items that must be decided now, since the next Area meeting isn't until March, hence the vote on items 1 21 in December. (Full list is in Delegate report.)
- After reading through the items, Pete made a motion to adopt all of them together. The District 36 DCM seconded the motion. Summary of the discussion:
  - A DCM who had been on Ad Hoc Literature stated how important it was to educate people about literature, and also mentioned how successful their workshops had been, in particular one on accessibility, as well as at EPGSA (where people learned much about the plain language Big Book agenda item). Also suggested possibly combining Literature with Grapevine, but did not make a formal motion.
  - ☐ Another DCM agreed 100% with the above sentiment.
  - □ The Delegate reiterated that we will not stop literature being discussed, and mentioned section in service manual about responsibility of DCM to bring up new literature: let's use our triangle. He also noted that last panel our subcommittees were spread too thin.
  - A DCM expressed concern over whether printed literature would still be distributed, since some are not very proficient in technology.
- A vote was taken on all 21 recommendations as a block:
  - ☐ There were 2 opposed with 1 abstention, so the motion carried with substantial unanimity.
- There was then minority opinion:
  - ☐ Another DCM echoed the earlier concern about access for those who aren't digitally inclined and strongly felt we need to continue to have printed materials.
  - A DCM fondly recalled the informative skit performed by Ad Hoc Literature at last year's EPGSA.
- Next, a DCM made a general request for information, regarding what Ad Hoc Literature actually "did" last panel:

- □ A member from the Panel 71 subcommittee then went to the mic to answer the question.
- □ There were then more questions which started to resemble full discussion; however, the Alternate Delegate raised a point of order, that was well taken by the Chair. The Chairperson clarified there could only be minority opinion from those who did not vote in favor, and general discussion was not allowed.
- District 51 (who had voted in favor) made a motion to reconsider the vote, which was seconded.
  - □ 14 voted in favor, so the motion to reconsider failed.
- The original motion was thus carried with substantial unanimity.

## **AFFIRMATION OF CONVENTION COMMITTEE CHAIRPERSON**

- The Delegate made the following motion: "In accordance with Area practice, the Delegate requests confirmation of Area 59's Panel 65 Delegate, Pat Fallon, to serve as the Panel 73 Convention Committee Chairperson."
  - ☐ The motion was seconded by the District 49 DCM, with the Area voting unanimously in favor.

54		This is my District 54 Quarterly Written Report for the fourth quarter 2022 (October - December 2022).  District 54 has 27 registered Groups. We meet monthly on the fourth Wednesday of each month at 7:30 p.m. We meet at Reformation Lutheran Church at 102 West Rose Tree Road, Media, PA 19063. This is our new meeting place as our previous church closed during the Pandemic. We have still been having hybrid meeting formats, with some GSRs meeting live in-person at Reformation Lutheran, and others attending virtually. I Bluetooth my laptop to a TV so that the live people can see and hear the virtual attendees. We regularly have about 9 to 16 GSRs present at each meeting, but that can vary from as low as 7 people to as many as 18 people in attendance. We have a speaker discuss the Tradition and Concept of the Month and then we do roll call, District Officer Reports, Old Business and New Business. Our monthly meetings typically run an hour to an hour and a half.  Our DCM is a member of the Corrections Subcommittee and attended multiple Corrections Subcommittee meetings virtually in October, November, and December 2022.
