## Sharing Session Notes | EPGSA Panel 73 April 15, 2023 Pre-Conference Sharing Session Calvary Baptist Church, Allentown, PA



- The session began with opening remarks by the Delegate, who explained the purpose of the event and its importance to help gain a "sense" of the Area's group conscience before attending the General Service Conference the following week.
- The format of the event featured a presenter who spent up to 10 minutes briefly explaining the background of the agenda item, after which there was open sharing from the floor.
- For a few items there was just open sharing, without a presenter.
- For each agenda item on the program, the main ideas from the comments shared are noted below.

Pete B., Delegate	<ul> <li>F   Are they going chapter by chapter? Are they re-writing Bill's Story etc.</li> <li>M   Quoted passage from 4<sup>th</sup> Edition Forward; defined for us the meaning of "integrity". It's "arrogance" to assume we can translate Bill W's words into plain language.</li> <li>M   A person who didn't read was able to get sober by attending meetings and sitting next to someone who could read. Since he and the speaker got sober the "old fashioned" way, we don't need to change.</li> <li>F   Overwhelming homegroup conscience is we need to do what it takes to make people find sobriety.</li> <li>F   Currently sponsoring someone who has lots of trouble reading and writing, and she needs help every few sentences to understand the basics. Felt this is a horrible thing being pushed since the 1970's by outside forces. Also complained about Delegate at 2021 GSC going "against" Area group conscience by being in favor. (History: Area opinion at PCCS was mixed and neither strongly in favor nor against. GSC vote was 110 in favor and 19 opposed. After minority opinion, motion to reconsider failed 27 to 103. Thus, passed at GSC with substantial unanimity.)</li> <li>F   Read an excerpt from last year's sample translations to point out the goal of this effort.</li> <li>F   It's probably needed by someone.</li> <li>F   Translations into other languages are already not using the exact words – it's the message that matters. What are we afraid of?</li> <li>F   Made point this has been kicking around forever. Process is slow enough. Consider this: "When I attempt to explain it to others, am I putting opinion into it?" We could all be mindful of that.</li> <li>M   Interested in what translation looks like. Homegroup concern is that it may supplant regular BB.</li> <li>F   Heard from many teachers/educators about how difficult our BB is to read. Also pointed out we don't submit agenda items in support of things already going on. (So, number of negative agenda items doesn't really indicate lack of support.) Our BB isn't going anywhere.</li> <li>M   BB not going anywhere. Simple BB is not a replacement, it's an addition.</li> <li>M   Noted (in boastful way) about how he took two 12<sup>th</sup> step calls already during event. Felt we are wasting our time here and not helping alcoholics. (Did not understand anything about PCCS or GSC.)</li> <li>M   In Panel 67, PCCS committee who read all of the background were unanimously in favor. (This was an earlier and similar agenda item.)</li> </ul>

If pamphlet said "Allah", would we want it?</li> <li>M   Has heard much support for this pamphlet, why are we throwing it out?</li> <li>F   Could professionals actually use this in today's environment? Not likely.</li> <li>F   ABE Intergroup literature chair – suggestion is to keep and update it.</li> </ul>

Recently found out about a last-minute alt-delegate who needs to attend conference, so is in favor of keeping alternate as informed as possible.</li> <li>M   Surprised it is not standard practice.</li> <li>F   Sees importance of alternate for a service position, the information shared by her counterpart really helped.</li> <li>M   Noted his wife is DCM; feels this request is important for transparency.</li> <li>F   Asked question: Why it isn't common practice?
