Eastern Pennsylvania General Service Assembly welcomes the Honorable Nancy L. Butts to our

67th Annual Convention and Assembly.

The Honorable Nancy L. Butts is the President Judge of the Lycoming County Court of Common Pleas. Born and raised in the Philadelphia area, she graduated from Lehigh University and California Western School of Law in San Diego, CA. Judge Butts has served the people of Lycoming County since 1986, when she started her career there as an Assistant Public Defender. In 1990, she became an Assistant District Attorney, then in 1995, she became the first woman elected to the bench in North Central Pennsylvania. Judge Butts founded and presides over Lycoming County's Drug Court (since 1998), Juvenile Drug Court (since 2004), and Mental Health Court (created 2008). In her profession, she comes in contact with many who suffer from alcoholism, and looks forward to applying what she learns this weekend to her work.


