# Meeting Minutes | EPGSA Panel 73

## **Meeting Opening:**

Susan M., Chairperson Panel 73, opened the meeting with the Declaration of Unity and thanked the hosting District.

Claire B., Area Office at Large read from "Our Great Responsibility" page 79-80, about our non-alcoholic Trustees. Bill W. spoke of how much time and effort were devoted to A.A., and the respect they gained. Bill highlighted the contribution they made, especially during the early 1950s when the 12 Traditions were adopted and noted the special legacy of Bernard Smith.

## **Acknowledged Guests:**

Past Delegates: Pat F.; Darren F. Special servants were noted, as was as the York area intergroup.

### **Traditions and Concepts:**

- Tradition 10 Heidi T. (D56)
  - Read long form of Tradition. Also read from the 12x12, which emphasized how A.A. has never been divided by an issue, or take a public side in any fight, no matter how worthy.
  - Related story of how her group has reached out to GSO for opinions on controversial issues. By not taking any sides on any issue, that is in a sense making a statement that we will not be drawn into any controversy.
  - ☐ The cautionary tale of the Washingtonians was also stated.
- Tradition 11 Devon C. (D21)
  - Noted Daily Reflections called "Active Guardians" which is a reminder that personal ambition has no place in A.A. and we are active guardians of our fellowship and the Traditions.
  - Humility is essential since we are all an equal part of A.A., and anonymity is an expression of that humility.
  - □ Also read from the long form, and noted "how great" this tradition is, and how it came from painful experiences. Devon also commented on how she or any member does not "promote" A.A. or their membership in our fellowship. She also looked at A.A. Guidelines, which has a lot to say about the internet and anonymity, which ties into Tradition 11 non-AA websites are the most problematic, because they imply affiliation with A.A.
  - Loves the Traditions checklist, especially asking if I promote A.A. so emphatically it becomes unattractive.
- Tradition 12 Liz F. (D48)
  - ☐ Read remarks prepared by Jill B. D40, who was unable to attend.
  - Listed some of the history of how our important tradition of anonymity developed, which included fear of publicity, both in how it made members spokespeople, and that it might attract too many people.
  - ☐ Ego and pride are also dangers, someone shouting "Look at Me" which might not be a good look.
  - □ A.A. Comes of Age we will be here when the depths of despair send us.
  - Also read from the A.A. group pamphlet, about how one should wait before speaking, and share judiciously, allowing time for the group conscience to speak.

## Roll Call | Secretary, Dan B.

• The Secretary conducted roll call. All 6 officers were present, and 38 Districts represented, for a total of 44 out of 54 eligible voting members. Please see the roll call tally attached at the end for details.

## Acceptance of Minutes from Prior Quarterly Meeting | Chairperson, Susan M.

- Susan verified members has read the September draft minutes (sent a month prior), and if there were any
  corrections or changes before voting to approve. (There were no corrections.)
- The D30 DCM made a motion to accept the minutes, which was seconded by the D22 DCM.
- The minutes were unanimously accepted, with none opposed.

### Acceptance of EPGSA Convention Minutes | Chairperson, Susan M.

- Susan verified members has read the EPGSA 2023 Convention draft minutes (sent 2 weeks prior), and if there
  were any corrections or changes before voting to approve. (There were no corrections.)
- The D51 DCM made a motion to accept the minutes, which was seconded by the D24 DCM.
- The minutes were accepted unanimously, with none opposed.

## Convention Committee Report | Convention Chairperson, Pat F.

- 718 total attendance it was a resounding success and Pat was grateful for everyone who helped it happen.
- March report will have financial results. They will also address issues with hotel waits for check-in and banquet.
- 104 responses were received; program was well received. Most registered online. Hospitality suite got great comments, although the room was too small. Banquet response was mixed.
- Suggestion to get groups and districts more involved.
- More interactive workshops; only voting members need to sit with districts.
- Nov 8-10, 2024, will be next convention, start planning now!
- Starting site selection committee for 2025.
- Comments and Questions:
  - DCM 45 felt convention challenge was a great idea and sparked interest. Pat will later provide statistics about the challenge participation.

#### Archivist Presentation - DCM Sharing Session Day | AREA ARCHIVIST, DONALD H.

- The Archivist provided a timeline of the DCM Sharing Session history, which is summarized below:
- October 1984 workshop for DCMs and past DCMs held without officers. Suggestion came to have a new workshop; structure made a recommendation to make it a yearly event.
- 1985 had workshop; 1986 Delegate recommendations for Structure was to continue the workshop as in years past. 1987 it was held again.
- They continued through 1980s, 1990s, and continued recommendations to continue.
- 1994 format changed to more of an orientation and a workshop.
- 2000s format changed for year 1 to be orientation, year 2 sharing session.

#### **Officer Reports:**

#### OFFICER AT LARGE, CLAIRE B.

- Loves all the changes that have been coming in for Fellowship Connection, please continue. Let her know if you need access, reports, or GSR kits.
- Provided updated list of groups.
- Thanked everyone for YPAA Share-a-Day in October.
- There will be another YPAA Share-a-Day in 2024 stay tuned.
- Questions and Comments:
  - D25 DCM noted GSRs are still having issues with GSR kits; Claire will assist her.

## TREASURER, TARA C.

Balances: \$29,320.61, \$14.956.27; provided 2023 FY P&L, as well as District contributions.

- FY2023: Expenses 90% of budget; contributions 112% of budget.
- Filed taxes, non-profit renewal.
- 1,200 contributions; 20% online.

#### SECRETARY, DAN B.

- No printed report; thanked everyone for assistance with registration at EPGSA.
- Keep submitting district minutes; available to speak at District meetings.

## CHAIRPERSON, SUSAN M.

- Updated service calendar; some Districts were changed for 2024 from what was provided earlier.
- Sent "congratulation" emails to those "chosen" to host an event in 2024.
- Implored people to not procrastinate in finding facilities; reach out to her for help.
- If you have any financial questions, contact the Treasurer Tara. She also handles signing any contracts.

### ALTERNATE DELEGATE, CURT C.

- Thanked everyone who volunteered; we had 115 in total.
- Noted flyer for Jan 7 Zoom meeting to plan EPGSA/SEPIA Share-a-Day.
- Questions/Comments:
- D51 DCM asked if there were any upcoming Share-a-Day events besides SEPIA, and what kind of outreach there has been with other intergroups.
  - □ Visited several intergroups. 4 want to have a SAD event but hopes they will combine events.

## DELEGATE, PETE B.

- Thanked everyone for attendance and support for our convention this year. Our speakers had nothing but wonderful things to say about Area 59 and their experience at our event.
- 2022 membership survey results are available on aa.org. There are graphs and lots of great ways to analyze the data.
- Pete noted email he sent about an additional survey from aa.org:
  - That survey was meant to compare how the results would be compared if A.A. did one itself vs. hiring a consultant. No information yet.
- Conference Literature Committee:
  - Reviewed all proposed agenda items for next Conference; they provided feedback to Trustees committee about what items would be the best to discuss, even though Trustees have the final say.
- Sharing Sessions at EPGSA
  - We had good participation thinks communication about future questions/sharing could be improved.

  - There is a new set of questions the Trustees committee developed, to further discussion about issues regarding changing literature, etc.
- A.A. Financial results are available upon request. Cash holdings have decreased, mainly due to expected FY 22 operating loss and inventory issues.
  - ☐ Contributions 4% lower than budgeted; literature sales on target.
- NERAASA 2024:
  - □ Primary role is to promote it as best as possible; exhorted everyone to build enthusiasm. It's a once in a decade event for it to be in Area 59, so shout it from the rooftops.
  - Pete also works to get participation from other Areas and meets with NE Regional Trustee. Wil be sending out a survey regarding topics for discussion.
- Summary of Questions and Comments:

- D24 DCM wondered if there could be a Google Group to collect feedback from upcoming survey questions, like what we do for PCCS.
- D53 DCM wondered how many literature items will be considered this year.
  - o 4 went to publishing; 54 are subject to EDW process. Similar items will be combined.
  - o Preliminary agenda for Conference will be available soon, which will show total number of items. That list is tentative, and 1<sup>st</sup> week of Feb will be final agenda, with background middle of Feb.
- D29 DCM Asked for update on Google Ads.
  - o 73<sup>rd</sup> GSC suggested sharing sessions, 2<sup>nd</sup> discussed this issue. Google termination of ads was reversed, but board could not explain why. There was no clear answer as to why or what the future will be.
- □ D30 DCM Plugged NERAASA 2024 t-shirts. Asked if groups could send back written questionnaires vs. less formal opinions.
- □ D66 DCM Wanted clarification about Google Group, is it for GSC questions or NERAASA survey.
  - o Intended for Google Groups
  - o Pete stressed the purpose is not meant to be a formal response of "answer 1 is this, answer 2 is..."
  - o It's more to get the "pulse" of the fellowship.
- □ D60 DCM question about purpose of NERAASA survey and audience.
  - o Answer: meetings are only with NE Regional Trustee, not all of AA.
  - Survey questions will come NERAASA host committee, and they have right of decision. Intention is to go to Delegates of other Areas.
- D44 DCM Noted sharing session with questions gave impression the Area was taking some kind of vote. Wanted Pete to make sure to emphasize it is NOT a vote and only to get a sense of the discussion.

#### **DCM Actions:**

- D43 GSO gave him contact info of a CPC person in his District for meeting lists.
  - Wants meeting lists for: Northumberland, Snyder, Montour, Union, Columbia counties.
  - D42 DCM responded that his District website has meeting lists for many of those counties.
  - Jessica T suggested getting zip code from meeting guide app.
- D43 Brought up motion that was rejected twice for Quarterly meetings.
  - Wants to get group conscience from DCMs about motions not being put on the agenda.
  - □ D51 DCM says it looks like there are no other districts with the issue.
  - D36 DCM wants to know why it wasn't put on the agenda.
  - Pete explained the function of the officer meetings is to determine what is best to be put on the agenda.

    The D43 motion was to "conduct business at each area meeting", which doesn't quite make sense since nothing prevents us conducting business.
  - Susan noted we don't try to "deny" per-se, but this motion was not needed since we can conduct business, if necessary, as was shown by the report provided by Archives.
  - □ Pete thinks we should be transparent about motions not put on agenda.
  - □ Ted DCM 27 commented on December Panel 69 we had business to conduct.
  - D58 DCM feels it would be good for transparency to have details around items not put on agenda.
  - D45 DCM noted how much work it took to get things on the agenda, and it required a lot of massaging the language. Also feels it is good to have transparency, but also found that some of his Districts "great ideas" were incorrect.
  - D43 DCM Thinks it's good to make sure good ideas in the area aren't lost because of wording issues.
  - D24 DCM doesn't feel we should put late ones on the agenda, just ones that need rewording, etc.

The chairperson then announced a break for lunch.

  - Participation of DCMs and GSRs do we have too many subcommittees and/or Area events?

## TREATMENT/ACCESSIBILITIES | DEVON C., DCM D21

- Have 2 new subcommittee members.
- Focusing on Accessibilities this year of Panel; would love to visit Districts to assist with needs.

## AD-HOC DIGITAL COMMUNICATIONS | TED C., DCM D27

- Major update is Digital Binder will be on Area website soon.
- Has all pamphlets in document with a single table, with embedded links.

## FINANCE | LAUREN B., DCM D24

- Decided Area should convert to QB Online from QB Desktop. Will have upcoming motion.
- Lauren then reviewed a short presentation on the FY 2024 budget see details in their presentation.
  - ☐ The proposed budget had already been sent out via email, including the narrative.
  - Lauren noted the budget is used as a planning tool; the committee analyzed past budgets from 2018 onwards, consulted with committee chairs/officers, and the Area Treasurer, to come up with best estimate of a good budget for the upcoming fiscal year.
  - □ Projections: Income, \$92,887 | Expenses, \$103,525 | Net: -\$10,638
  - □ The deficit is expected; we have enough money in our checking account to cover the deficit spending.
  - □ Lauren then went through a breakdown of the budget showing the various categories as a pie chart; their presentation will be sent to DCMs and is available upon request.
  - Some of the notable expenses: Additional Treasurer budget for new laptop and backup hard drive; \$7,500 for EPGSA convention, \$9,000 GSC; committee budgets are between \$1,900 and \$3,700, which is lower than some requests, but somewhat higher than last year.
  - The cash flow forecast estimates enough money to cover expenses will be left in the checking account at the end of the fiscal year.
- Questions about the budget after presentation:

- ☐ Grapevine Chair it was confirmed that funds spent on literature for Grapevine do not come out of the GV budget and appear under "Cost of Goods Sold" because we will make the money back through sales.

  Question due to wording in narrative that implied costs for their line-item.
- □ Tim S., DCM D65, question about the projected deficit, and if we have a plan so we don't have funding issues in future panels. Answer: we typically run under (worst case scenario). Future budgets would not have a deficit if we do not have the funds to cover it.
- Steve B., DCM D41 question if Structure motion for additional budget is included in this. Answer: it was for last year.

#### **New Business:**

#### **FINANCE MOTIONS**

- Lauren then read each motion:
  - 1: The Finance Subcommittee unanimously recommends that Area 59 contribute \$7,200 to the General Service Office in addition to the Delegate's minimum General Service Conference fee of \$1,800.
    - o **40** in favor, none opposed. The motion carried with substantial unanimity.
  - 2: The Finance Subcommittee unanimously recommends that Area 59 adopt its FY 2024 Budget Proposal.
    - 40 in favor, none opposed. The motion carried with substantial unanimity.

#### **Unfinished Business:**

#### STRUCTURE SUBCOMMITTEE RECOMMENDATION

"We of the Structure Subcommittee would like to recommend the following updates to our EPGSA Structure Manual to more accurately reflect the current customs and business practices for Area 59 as well as some minor grammatical changes."

- It was noted changes are in red next to the original.
- Summary of Discussion:
  - Jess T., GV Chair: their first submission was modified and sent back to Structure. Some suggested wording of their section was not considered. It had language about working with other local GV subcommittees.
  - Alex N., Structure Chair, explained that nothing in the Structure manual prevents collaboration with others, and the subcommittee felt it was not required for inclusion, since the spirit of the manual is to be a guide.
  - Pat DCM D38, question about Archives history section that will be completed soon. How will that be updated in the manual? Alex began to answer that this is just one update, and future revisions can still be proposed and reviewed by structure...
  - Pete B. raised a point of order that Alex must direct discussion to the Chair. The point of order was well taken by the Chairperson.
- The main motion was read again by Alex, and then voted upon.
  - □ **38** in favor, none opposed. The motion carried with substantial unanimity.

#### DISTRICT 23 MOTION | MICHAEL R., DCM

"Area 59 should strive to offer all Pre-Conference Sharing Sessions (PCSS) and at least one annual Delegate's Conference Report (DCR) in either an online or hybrid format."

- Due to the inability of the D23 DCM to attend because of rainy weather and the long travel time, he requested it be postponed until the next meeting.
- After some confusion about a "motion to table", Pete B. made a point of order that although the motion is on our agenda, it cannot be presented due to the motion submitter's absence. The point of order was well taken by the Chairperson.
