Meeting Minutes | EPGSA Panel 73 September 8, 2024

Area Quarterly Meeting, Q4 Neshaminy Mall 707 Neshaminy Mall Bensalem, PA 19020



Meeting Opening:

Susan M., Chairperson Panel 73, opened the meeting with the Declaration of Unity and thanked the hosting District.

Dan B., Area Secretary Panel 73, read from "Our Great Responsibility" pages 177-178. Bill W. spoke about how groups of people tend to get dogmatic over time, and how that can be a liability. As AA continues to gain new members in ever increasing diversity, it is important to never force our views on anyone, and always be inclusive rather than exclusive.

Acknowledged Guests:

Past Delegates: Marty S., P51; Pat F., P65; Paul M., P67. Special servants were noted.

Traditions and Concepts:

- Concept 7– John H. (D66)
 - □ John read the short form of the Concept, which specifies the role of the trustees, who have legal authority; it also notes the Conference Charter is not a legal document and relies on the force of tradition.
 - He read the closing talk of the 1960 Conference and had handouts for those interested.
 - □ John relayed a brief history of the "controversy" in 2017 when the Trustees initiated a lawsuit regarding the original Big Book manuscript it was noted they did have the legal authority to do so. However, many in the Fellowship were not happy with this decision and used the power of the purse as explained in the Concept.
- Concept 8 Ruth D. (D60)
 - Ruth read from the short form of the Concept, which details which tasks the GSB handles, and the ones for which it has more of an oversight role.
 - She then went into detail about how the GSB carries out the will of the Conference, yet only appoints the Directors of our two corporations. The Board does not need to manage the detailed day-to-day operations, and delegates its authority.
 - Ruth then gave an example of how when the Conference voted to eliminate staples from the Grapevine, the board had the authority to carry that out, but it was their decision on how the details would work.
- Concept 9 Lauren B. (D24)
 - □ Lauren read the short form of the Concept, which notes the importance of leadership and vision.
 - It was noted the humility that would have been required for Bill and Bob to pass on the leadership of AA affairs to the Conference and Trustees.
 - She noted how when she had a leadership role at work, she turned to Concept 9, since its spiritual principles apply to all parts of our life.
 - Many of the key characteristics of true leadership were noted, and Lauren noted how she had to apply those principles to herself.
 - ☑ Servant first, Leader second. Lauren closed by talking about the spirit of rotation.

Roll Call | Secretary, Dan B.

• The Secretary conducted roll call. 4 officers were present (OAL Clare B. could not attend), and 35 Districts represented, for a total of 39 out of 53 eligible voting members. Please see attached roll call tally for details.

Acceptance of Minutes from Prior Quarterly Meeting | Chairperson, Susan M.

- Susan verified members has read the June draft minutes (sent a month prior), and if there were any corrections or changes before voting to approve. (There were no corrections.)
- The D51 DCM made a motion to accept the minutes, which was seconded by the D31 DCM.
- The minutes were unanimously accepted, with none opposed.

Convention Committee Report | CONVENTION CHAIRPERSON, PAT F.

- Pat noted the convention is open to everyone, not just DCMs and GSRs!
- Hotel contracts have been secured for the 2025 and 2026 conventions. Nov 14-16, 2025; Nov 13-15, 2026.
- Outreach and logistics are ongoing. Stay tuned for e-blasts and check the website for color versions of forms/flyers.
- Pat exhorted everyone that we need volunteers. Hospitality donations are welcome ours is the best in AA.
- Registrations can be canceled until Nov. 1. Hotel reservations may be made until Oct 8 and canceled until Nov.
 6. No shows and cancelations after that date will result in the total room rate being billed for the weekend.
- Comments and Questions:
 - Ruth D., DCM D60 asked if electronic voting would be ready for this year? Answer: Nope.

Archivist Report | AREA ARCHIVIST, DONALD H. - EPGSA ELECTIONS HISTORY

- Donald expounded upon the history of how our Area election process evolved over the years.
- The earliest information is from 1954, who essentially told people to come to his garage and vote for him. 83 groups, 4 officers, and 6 District reps.
- Donald has been unable to verify the "rumor" that Bill W. appointed our first two Delegates. (No elections.)
- 1962 and 1964 featured elections with a short time to "caucus" and discuss election procedures, then there was an election that took less than an hour.
- In 1976, there were many complaints from the DCMs regarding the election being at the end of the program, the lengthy amount of time, etc.
- The Area voted to adopt a 2/3 majority and Third Legacy Procedure for all officers in 2008. Eventually, after much discussion, our current timeline and procedure was adopted.

Officer Reports:

OFFICER AT LARGE, CLAIRE B. | (CLAIRE WAS ABSENT - THE CHAIRPERSON READ THE REPORT.)

- YPAA & Area 59 SAD, Sunday Oct 6, 3 PM 6 PM. Subcommittees are encouraged to bring a display.
- For workshops at EPGSA, subcommittees who need equipment, such as a projector, should talk to her.
- Claire would be happy to discuss the OAL position with all who are interested in standing. Note: the newly elected OAL will need to have room in a vehicle to transport ALL current OAL materials.
- Please keep your GSR and District records up to date.
- Questions and Comments:
 - Ruth D., D60 DCM will a Honda Accord be big enough? Answer: No.
 - Pete B. noted he was elected as OAL a year in which he came in a friend's car people will help you out!

TREASURER, TARA C.

- Tara noted that reporting issues since the migration to QuickBooks online, so she will email the P&L and District contribution split in about 2 weeks.
- Continues to process treasurer transactions storage unit paid; liability insurance paid; semi-annual taxes paid.
- Balances: \$29,325.03 (Savings), \$9,143.87 (Checking).
- Tara is running behind due to a death in the family but will be up to date soon please be patient.
- It's important to have all expenses in by November 30, since we have a new treasurer December 1.

• Also working on Area Day planning; noted the flyer and the date on October 5 in District 40.

SECRETARY, DAN B.

- Dan stressed the importance of volunteers for the upcoming convention we only have about 45 so far but need many more! Registration is especially important. Please sign up on the volunteer sheet being passed around!

 - The online form allows choice of volunteer type and time, so please share with the GSRs in your District.
- Dan reiterated the importance of sending district minutes and DCM reports.

CHAIRPERSON, SUSAN M.

- Susan noted the location of the December quarterly will be in Lititz PA, near Lancaster. The details will be posted on the Area website.
- Please note the updated service calendar, which does have a few items for 2025.
- There will be the final Pre-Area Officer meeting, TBD after the election; next is the changeover meeting in December.
- Susan noted upcoming events: YPAA-SAD, Area Day, and our EPGSA convention.
- She expressed gratitude to all the Districts who hosted events during this panel.

DELEGATE, PETE B.

- Pete expressed his gratitude for the invitations he's received from Districts, and the opportunity to share one on one with people, to listen to "the heartbeat of AA" in Eastern PA.
- Although people have been very enthusiastic about getting information and participating, it does require some sacrifice. Please think of what each of you can do when rotating out, to assist the next person in your service position!
- Pete will email out to everyone a folder with all his attachments there is also a QR code.
- There is a Plain Language Big Book flyer, which will be in an 8x11 format like "Our Great Responsibility"; will be available on November 1st. There is also a flyer with information about other new literature please review.
- The most recent Conference Report is available online, and 2 hard copies were given to each DCM. More are available, so please take them.
- AA Internation Convention is in July 2025 room booking will be go live on September 10 at 12 PM. There is information and a QR code with details on available hotels and rates in his packet.
 - ☑ We will be co-hosting a hospitality suite with Area 60 more information forthcoming.
- NERAASA 2025 will be virtual, including planning.
- Deadline is September 30 for proposed agenda items for next year's GSC. Pete encouraged more agenda items in Area 59 to be brought forth at the Area level, so we can have a robust discussion, and review them together as an Area. We could gain a lot of valuable feedback and understand the group conscience.
- EPGSA Convention:
 - GSRs and DCMs should be supported by their respective groups/districts please attend!
 - Annual written officer and subcommittee reports are due no later than October 31. (No verbal reports).
 - □ There is nothing more important a GSR can do than participate in the election of our officers.
 - □ We will vote for a nominee for Trustee-At-Large, to be elected at the 75th GSC.
 - □ There is a draft program included in the information packet. More workshops are needed if a subcommittee wishes to hold a workshop, please contact Pete as soon as possible.
- Summary of Questions and Comments:
 - D24 DCM: When are subcommittee recommendations due, October 31st? Answer: Probably a little later; Pete will send out a communication. Note: the deadline actually will be October 31st.

D45 DCM: Adam relayed how last year his District had many people who were willing to volunteer since they are so close but balked at having to pay for registration (only volunteering). Is there any thought of allowing people to volunteer without having to pay registration? Answer: "I hear you." It will be discussed at the next Convention Committee meeting. Also, the Convention Chair heard the comment. Registration is only \$25 this year too.

DCM Actions:

- D68 DCM
 - Rosendo at our last D68 meeting, a GSR brought point to be discussed regarding La Viña. Since there was a discussion at the last GSC regarding the sustainment of La Viña magazine. Could we bring a suggestion:
 - That La Viña accept voluntary contributions from the groups. Since the numbers are so small, and there aren't as many subscriptions as possible; we fear we may never be self-supporting.
 - Wonder if Hispanic groups could contribute to La Viña...
 - D24 DCM had a similar discussion of how to help. They purchased several subscriptions but have yet to figure out where to place them.
 - D38 DCM to clarify...is the request for AA groups to contribute financially to La Viña. Answer: YES.
 - Pete B., Delegate A difficult part of general service is sometimes the legal and the spiritual. I'm not certain that the corporations Grapevine is able to legally accept contributions. He will find out more information.
 - A proposed agenda item would be the only way to make that a change. He's willing to be a resource if the District wants to create that proposal.
 - Rosendo that's exactly what we want (assistance in creating an agenda item)!

The chairperson then announced a break for lunch.

Subcommittee Reports:

ARCHIVES | JENN F., DCM D47 | (GIVEN BY PAT D. D38 DCM, DUE TO JENN'S ABSENCE.)

- Continued to hold in-person meetings at the storage unit; held online meeting to discuss Archives business. Also, continued to attend Area events and District meetings.
- Sent final version of Area history revision, as voted upon at last Area meeting.
- After 2 years of painstaking research, Archives finally ordered new District display binders! To have the new binders ready for display at EPGSA, they have increased the frequency of meetings to prepare the new binders.

CPC/PUBLIC INFORMATION | ALEX B., DCM D43 / DEB S., DCM D30

- Deb S. had first joint CPC/PI meeting to review what each subcommittee had been working on. Also agreed on workshop for EPGSA Anonymity and Social Media. Working on recommendations for next panel.
- Alex B. Continue to attend events; working on adding Area 59 AA listing to PA 211. Added the Spanish Intergroup to the Area 59 website. Will be discussing what new combined shades should look like, and what literature the subcommittee will have.

CORRECTIONS | RUTH D., DCM D60

- Committee has met once to divide up workshop coverage.
- Committee was contacted by a director of treatment service regarding vetting of volunteers who bring in meetings to prisons.
- Main concern was ability to get references for potential volunteers aside from the using screen process.
- Informed her that there is no central list, and it is primarily the responsibility of Intergroups to provide volunteers. She provided contact information for local intergroups.

FINANCE | LAUREN B., DCM D24

• Finance report will be emailed after the Area meeting.

- Assisted Districts with a budget.
- Been preparing physical 7th Tradition packets for EPGSA.
- Working on subcommittee recommendations for next panel.
- Will have a joint workshop with Structure at EPGSA how to best use 7th Tradition money at all levels directly.

GRAPEVINE / LA VIÑA | JESS T., DCM D58 | (LIZ F., D48 DCM GAVE REPORT IN JESS'S ABSENCE.)

- Ordered new literature for sale at EPGSA and other events.
- Will inventory all literature afterwards for the next committee.
- \$495.36 of literature is still missing from NERAASA (could not find). Will reimburse Area from their budget.
- Will give away past issues of GV/LV at EPGSA.

STRUCTURE | ALEX N., DCM D51

- Made updates to Structure manual that were voted on: Finance changes, Structure changes, Archives history revisions.
- Will have printed versions, including QR code that links to many useful resources.
- E-book is in production and will be on Area website by EPGSA.
- Digital library of District structure manuals is now available on website.
- Suggestions on how to create a structure manual is also on website.

TREATMENT/ACCESSIBILITIES | DEVON C., DCM D21

- Continues to work with BTG and Intergroups
- Will be presenting motion on behalf of BTG.
- Open to suggestions on how they could support other subcommittees, districts, intergroups with accessibility issues.
- Working on contact list of information for items such as veterans' groups. Also suggesting meeting listing include more categories than usual, such as veterans, baby-sitting, etc.
- Submitted info on their subcommittee section on website to Digital Comms.

AD-HOC DIGITAL COMMUNICATIONS | TED C., DCM D27

- Continues to keep digital binders on Area website updated as literature changes.
- New version of WE is up on the Area website; another issue will be out by EPGSA. Collen is new WE editor.
- Treatment/Accessibility will be final subcommittee to have a "more information" section on the website.
- Ted also noted their digital placards, which are taller than pamphlets, so they show the QR code when placed behind existing pamphlets. They will be up soon on the website.

New Business:

- TREATMENT/ACCESSIBILITIES SUBCOMMITTEE MOTION | DEVON C., TREATMENT/ACCESSIBILITIES CHAIR "The Treatment Accessibilities Subcommittee recommends that Area 59 approve "Bridging the Gap's" pamphlets and placard card for use as they carry the Area 59 Logo."
 - Final printing of all 4 pamphlets took place in April, and the Area Web Site was updated. In June at the Area Quarterly meeting (Q3) they were presented for the Area Committees consideration to be voted on at (Q4) in September.
 - Issues were raised regarding level of detail of information collected, as well as anonymity concerns.
 - Intergroups relayed concerns that clients could be tied back into the legal system after entering their information. Although this concern was not valid, the perception was. The forms were modified to address these concerns.
 - Forms were revised taking into consideration input from all intergroups to better meet the needs of the Area.
- The Chairperson, Susan M., noted that since the motion came from a subcommittee, it did not require a second.

She then called for a motion (unanimous consent) to suspend the rules so that our BTG Coordinator Jim L. could speak. This motion was seconded – nobody objected.

- BTG Coordinator, Jim L.:
 - Explained that this motion came through Treatment because BTG does not have a direct voice.
 - Since our pamphlets are in display throughout the Area, and other Area materials have gone through the normal approval process, for transparency they wanted this to be approved by the Area.
- Summary of Discussion. Note: due to the lengthy discussion, comments are summarized.
 - Alex N., D51 DCM: BTG is a service the Area provides, and Treatment and Corrections is meant to be first point of contact regarding the Area program. He inquired if the Corrections Subcommittee had been asked to provide input. Ruth affirmed she had participated regarding updates.
 - BTG Coord: Each subcommittee had one representative to discuss pamphlet changes. It has been ongoing. (Also affirmed that both Treatment and Corrections had a representative to discuss the changes.)
 - D51 DCM: This was not presented as a motion under new business at the last Area meeting. "If this is a pamphlet that is provided by a service for Area 59, I personally believe that this should go back to the groups to be reviewed in detail."
 - □ *D51 DCM then made a motion to postpose indefinitely*, since he felt it shouldn't be decided today, and because December is the changeover meeting.
- Discussion highlights after Alex N. made the motion to postpose indefinitely:
 - BTG Coord: Explained more about the background, and how the original BTG materials were never officially approved. Originally this was just going to go the DCMs, but then decided it would be better to present as a motion and discussed.
 - D51 DCM: Raised a point of order regarding his motion not being asked for a second. The point of order was well taken by the Chair.
 - John H., D66 DCM: John seconded the motion, but wanted clarification regarding where this would leave the original motion.
- Discussion highlights after John H. seconded the motion to postpone indefinitely:
 - Devon C., T/A Chair: The pamphlets have already been printed and are in use. They will continue to use the new pamphlets regardless of whether this is approved. It is a formality and unprecedented situation – were' doing the best we can in the moment.
 - BTG Coord: Reiterated this is not a structure change, although it might be useful to have a future policy regarding subcommittee literature approval. It does not need to be postponed.
 - D51 DCM: Intent is not to put a chokehold on BTG literature and understands its necessity. Also, feels strongly that we serve the groups, so why would we not give the groups an opportunity to discuss and vote on such important literature.
 - Pat D., D38 DCM: How can any group or subcommittee within the Area revise pamphlets without being approved by the Area?
 - BTG Coord: The original pamphlets were *never* approved, so this is an attempt to "right a wrong", improve them, and do things the right way.
 - D38 DCM: If groups had a chance to review this, that's great.
 - T/A Chair: We gave everyone the new pamphlets and said in our report to take them back to the Districts.
 - D38 DCM: Can appreciate wanting to correct past wrongs but cautions against moving forward if it has indeed not been reviewed.
 - □ Tara C., A59 Treasurer: Asked for a point of clarification, that we're not voting on the changes. We're just voting on the pamphlets. Answer: Correct.
 - BTG Coord: We are voting that this is okay to be Area 59 literature, since it has the Area logo.
 - □ Tara C.: So, we had trusted servants that have been either appointed or elected to positions to create the literature and we're just trying to get an okay that it is of Area. 59.

- □ Lauren B., D24 DCM: The only changes is making them more anonymity protected plus the Area logo. We are just approving the logo (being on the pamphlet).
- Adam S., D45 DCM: We were given the information at the last meeting, and the minutes make it clear we were to take this back. We're just putting the pieces back together.
- □ Neil D., D36 DCM: Against postponing indefinitely, for approving the changes. A BTG volunteer thinks they are perfect.
- Ruth D, D60 DCM: This is a formality only; nobody had problems with it before; in favor of the BTG literature.
- □ D40 ADCM (acting as DCM): Does not really understand this motion it's just to put the logo on and protect anonymity, right? Don't we also have right of decision?
- D24 DCM made a motion to call the question.
- Summary of discussion after the motion to call the question:
 - □ The Chairperson began to explain that the motion to postpone indefinitely only required a majority vote, but then the D36 DCM raised a point of order that we should be voting on the motion to call the question.
 - □ The point was well taken, and then it was discovered we had not gotten a second. The D31 DCM then immediately seconded the motion to call the question.
 - □ The Area then voted: 38 in favor, 0 opposed. Thus, debate ended.
- Susan then stated we were now voting on the motion to postpone indefinitely, which requires a simple majority:
 2 in favor, 36 opposed. There was no minority opinion. Thus, the motion failed.
- There was no further discussion, so the original motion was read again. The Area then voted:
 - □ 34 in favor, 3 opposed.
 - Minority Option:
 - John H., D66 DCM: Noted the "revised" pamphlet has the old Preamble. It really needs the actual approved preamble.
 - Nobody on the prevailing side wished to reconsider the vote.
 - Thus, the motion carried, and the Area approved the new BTG literature.
