As the Area's Intergroup Liaison, I'm excited to share about the 2 upcoming Share A Days with Harrisburg Intergroup and NEPA Intergroup. Unfortunately, due to unforeseen circumstances, we were unable to hold a Share A Day with Pocono Intergroup. After traveling to almost all of the Intergroups in Area 59 over the year, and after much prayer, reflection, and investigation, I'd like to express my excitement to bring back a workshop called *All Intergroup Day* in 2026. Rather than trying to plan multiple Share A Days with different Intergroups, this forum used to be held once a year to bring all of the Intergroups and Districts by Committee together in a central location to discuss things that have been working in their committees, hardships they may need guidance on, or operational and procedural inefficiencies. We will still have our standing tradition of a Share A Day with SEPIA, but this is a great way to gather all of the Intergroups and Districts by Committee together for a day of mutual collaboration.

As the Area's YPAA Liaison, I'd like to extend a heartfelt thank you for allowing me to attend the Pennsylvania State Conference of Young People in Alcoholics Anonymous. Their enthusiastic way of attracting newcomers is contagious and I am thrilled to have been able to witness first hand, literally right in front of me during the sobriety countdown on Saturday night, a young lady with less than 24 hours sober in a room of over 700 sober alcoholics. Also, I'm excited to welcome you to the upcoming YPAA & Area 59 Share A Day to discuss the history of regional conferences like NERAASA and NERF on the General Service side of things as well as the history of PENNSCYPAA and ICYPAA. Lastly, I'd like to announce the regional conference known as NECYPAA which was the New England Conference of Young People in AA has expanded to include all 18 General Service Areas in the Northeast Region, thus



changing the name of the conference to the Northeast Conference of Young People in AA, keeping the same acronym.

Additionally, we have decided to pause the GSR Forum and take a step back to review its broader impact and effectiveness, as well as address various concerns and operational aspects. We will still be hosting Ken T., our Northeast Regional Trustee on the first Monday of October, but all meetings from November moving forward are currently on hold while we explore the matter further.

To my surprise, after looking at the Area maps, there are seemingly 4 counties in the center of Pennsylvania that are, on paper, only partially represented or completely unrepresented in our service structure. The counties are Clinton County, Fulton County and parts of Centre County and Huntingdon County. I'm not sure if there are any meetings or groups out there, but if there are, we'd love to hear from them!

Lastly, we are 60 days out from EPGSA and we need volunteers! Volunteers can fill out the form online, scan the QR code, or simply contact me or the Area Secretary. They can select their preferred time to assist and we will do our best to accommodate their requests. Please ask your GSRs to get involved, as we cannot function at any level of service without their participation.
