2025 International Convention

• I'd like to state my sincere gratitude for the Area supporting my attendance at the 2025 International Convention in Vancouver, BC. It was an incredible event and wonderful way to connect with other alcoholics around the world. Not only did I volunteer for five different events (three that were CPC related), I also got the chance to meet others in service and share more about our experiences carrying the message of A.A.!

75th General Service Conference

- The final Conference report for the 75th General Service Conference will be available online 9/17, with the printed reports available shortly after. The link will be posted on the Area 59 website, and printed reports will be available at the EPGSA Convention. Let me know if you would like additional copies for your District.
- I have given 7 reports of the 75th General Service Conference, with another scheduled in October. Thank you to all the Districts, groups and workshops that invited me to visit and report on the Conference. This is such an important part of my responsibilities, and I thank you for helping me inform A.A. members in Eastern PA.
- I met twice with the CPC/Treatment & Accessibilities Trustee Chair, Dawn Klug, to review the progress of various items important to the CPC Conference Committee, as well as general updates:
 - We decided to meeting approximately two weeks before and again two weeks after each General Service Board weekend, to review progress and updates regarding CPC items of interest.
 - o A.A.'s premium Linked In subscription got budget approval and will start soon.
 - The "redirected" pamphlet to professionals was sent to publishing, with a status update forthcoming.
 - The PI Comprehensive Media Plan was discontinued due to the time-consuming nature of compiling metrics and statistics that had no real actionable value. The future strategy is unknown at this time.
 - o The Public Information Trustees Committee is working on the next A.A. membership survey.
- The deadline for new PAI submissions is September 30th. As always, anyone submitting a PAI is encouraged to gather as much feedback as possible, and ideally presenting it before the Area for discussion. The timeline for the upcoming 76th General Service Conference will likely be as follows:
 - o October: General Service Board reviews preliminary agenda.
 - November: Preliminary agenda sent to Delegates.
 - o January: Final list of agenda items available after Trustees January Board weekend
 - o February: Background info sent to Delegates
 - o April: Area 59 Pre-Conference Sharing Session.

Annual Reports:

- Each officer and subcommittee chair needs to create a written annual report to present during the Assembly at EPGSA (2 minutes max). Reports are due, in English and Spanish, no later than October 31st.
- o After our meeting, I will send out a separate email with the report template and more detailed instructions.
- Note: You do not need to produce a written report for the December Ara meeting, unless there are significant updates you would like to share with new information not in your annual report.

• Draft Program:

- Each of you has a copy of the latest draft, which has also been posted to the Area website.
- o I am excited for our 3 guest speakers A G.S.O. staff member, a Class A Trustee, and a Class B Trustee!
- There will be an Assembly Discussion after officer and committee reports, to give GSRs a chance to share their group conscience. There are two questions to bring back to your groups for feedback, both related to the 75th GSC advisory action regarding a new process to classify Founders' literature:
 - What general process should we use to classify writings as Recovery, Service, or Archival/Historical? Who should determine the classification?
 - What literature do you consider to be in each category of Recovery, Service, or Archival/Historical?
 - Time permitting, the remainder of the discussion will be a "what's on your mind" session to discuss other general topics.
 - I will send out an email with more details and some brief background information after our meeting today.
- After the assembly closes, there will be a general session open to all, with Class B Trustee Carolyn W., who
 will give a report on A.A.W.S. and the General Service Board.
- o In addition to the 7 subcommittee workshops, Class A Trustee Dawn Klug will provide an update on CPC/Treatment & Accessibilities, followed by Carolyn W., who will discuss General Service Board efforts to improve communication, and the various ways members can stay informed.

General Service Updates

- 2025 2nd Quarter Financial Results: (See docs folder for details.)
 - o The report contains the complete figures, charts, and much more, including reforecast budgets for A.A.W.S. and AAGV/La Viña.
 - GSB Contributions were 10% less than budget, and 17% less than the prior year. The operating surplus was \$56K vs. the budgeted \$221K.

- o GV print subscriptions declined 8% compared to prior the year.
- Compared to the prior year, the GV bottom line improved by \$246k roughly halving the loss from the first six months of 2024. While App subscriptions across all sources increased dramatically from last year, decreases in print subscriptions offset those gains, resulting in nearly flat performance across all subscriptions.

 - All other general communications I received from the General Service Office and General Service Board, such as memos from the GSO General Manager, Trustee vacancies, etc.

 - Regional Forums are hosted by the General Service Board and "open" to all A.A. members or anyone
 interested in A.A. They are designed to enhance trust and communication between A.A. members, the
 General Service Board, Staff, and Directors from the General Service Office and AA Grapevine.
 - This year it will be in Providence RI from December 5-7, at the Omni Providence Hotel, with reservations open. Please see the flyer or <u>aa.org</u> for more details. This is a great service event, and everyone is encouraged to attend!

 - The purpose of <u>NERAASA</u> is for GSRs, DCMs, Area Committee members, and Intergroup/Central Office Representatives from the Northeast Region to discuss General Service Conference-related issues and those affecting A.A. as a whole, as well as pertinent aspects of recovery, unity, and service common to the Areas of the Northeast Region.
