 LIAISON AS PART OF THEIR DISTRICT MEETING.
 - D36 THEY ARE HOSTING PENNSCYPAA. THE DISTRICT VOTED ON HAVING A PENNSCYPAA LIAISON WHO REPORTS MONTHLY AT THE DISTRICT MEETING.
 - Delegate Area 59 Alt Delegate is the YPAA Liaison
 - D48 As past host of PENNSCYPAA, they had a big issue with the old timers not knowing what it was. There is a flyer that states what is PENNSCYPAA, and she provided every meeting with those and it helped.
 - o D67 There is an Area 59 / YPAA SAD coming up.
 - AREA CHAIR IN D35, THERE IS A YPAA MEETING AND THE DISTRICT ACCEPTS CONTRIBUTIONS FROM THEM, AS DOES AREA 59.
 - ALT DELEGATE GSO ALSO ACCEPTS CONTRIBUTIONS FROM YPAA.
 - D63 BASIS FOR ARGUMENT IS THAT PENNSCYPAA IS AN AA GROUP -
 - D45 ARE THERE ANY ACTIONS FROM THE GSRS? THEY ASK ABOUT WHAT IS GOING ON IN THE GROUPS. ANYONE IS ALLOWED TO HAVE THEIR OPINION.
 - D55 WHEN DID WE GET INTO THE BUSINESS OF SAYING WHO IS PART OF AA AND WHO ISN'T. WHEN DID HAVING A GSO # MAKE A DIFFERENCE?
 - o D51 Area 11 has a YPAA rep that has a vote in the Area meeting.
- ANDREW D., DCM D66 –

- Using District Funds for Scholarship for GSRs to attend EPGSA
 - ASKED BY A SHOW OF HANDS HOW MANY DISTRICTS PROVIDE SCHOLARSHIPS? HANDS WERE RAISED.
 - D63 THEY HAVE AN SHE WAS AGAINST. GROUPS SHOULD BE SELF-SUPPORTING. DISTRICT FUNDS
 ARE TO BE USED WITHIN THE DISTRICT BUT RUN INTO ISSUE ON WHAT GROUPS THEY FUND AND WHICH
 ONES THEY DON'T.
 - D37 Was against it. It is approximately \$600 for each. Biggest concern was how to do it equitably. Also, what if they don't go and they pay for it?
 - D51 Never funded any individuals. Had picnics where they give away registrations as DOOR PRIZE. PROPOSED THAT THEY RENT A VAN FOR ALL MEMBERS WHO CAN'T AFFORD TO GO / JUST WANT TO GO FOR THE DAY.
 - D27 DID SUPPLEMENTAL GRANTS (\$100 \$150) TO SUPPLEMENT IN THE PAST). LAST YEAR, THEY GOT A VAN AND HAD A VOLUNTEER DRIVE TO AND FROM EPGSA. THEY GOT SOME PEOPLE TO ATTEND WITH THE VAN. THEY WILL ALSO CONTINUE WITH GETTING GSRS TO HAVE THEIR GROUPS PUT FUNDS ASIDE FOR THEM TO ATTEND. WILL MAKE SUGGESTION TO GSRS TO HAVE GROUPS PUT MONEY AWAY EACH WEEK SO IT WON'T BE TOO COSTLY. WILL DO SOME SUPPORT THIS YEAR.
 - D67 He does something similar to what Pete (Convention Chair) said (\$20 a week set aside). They are doing a countdown to EPGSA. They start talking about it at the Beginning of the year to be self-supporting to send the GSR. They also have it in the Structure Manual. They can attend with District Funds, if they are available. Conversation starts way before, they vote on it, and it is a case by case basis.
 - D21 AA GROUP GSR IS THE MOST IMPORTANT JOB. THE MONEY SENT TO DISTRICT IS FOR THEIR BUSINESS AT THAT LEVEL. FUNDS ARE DIFFICULT AND IT SHOULD BE USED FOR DISTRICT BUSINESS.
 - D55 In the past, they have had Scholarships for the day pass available. In order to apply for one, they need to provide a letter from the Home Group. It's not a stay for the weekend type of thing. They do just the registration for the day. They announce it, then accept the nominations. Bad feelings have come up in the past (not reimbursed in full because the District couldn't provide the entire reimbursement).
 - D45 Last Panel, District had enough funds to do this. They didn't pay up front for anyone to go. There was a stipulation to it. If they were in their seat ready to vote, they would be reimbursed. Not paying for hotel.
 - ALT DELEGATE SOME AREAS WILL DO LOTTERIES TO SEND GSRS TO NERAASA. ANOTHER
 OPPORTUNITY IF THE DISTRICT WISHES TO DO THAT.
 - D30 \$300 APPROVED FOR THE DISTRICT. COULD BE FOR SMALLER AMOUNTS. IF MORE THAN 1
 APPLY, PUT NAMES IN THE HAT. MADE SURE IT WAS CONFIDENTIAL.
 - o D67 If it comes down to keeping money in district, GSRs are future district officers.
 - AREA SECRETARY FOR D24 SCHOLARSHIP FOR THE DAY AND BANQUET (\$95) TOTAL HAD THE FUNDS BUT NO TAKERS.

Tom W., DCM D67 –

■ Women's Meeting Sparked some discussion over the last couple of Months – Someone transitioning from being a woman to a man attending the Meeting – Wanted to know precedents if they can change their Meeting description to be "those identifying as women" – Pamphlet says that if they are alcoholic, they can call themselves an aa group. Shouldn't kick out based off of gender. Ran into the issue on how confident are they about being a women's group? And there was the issue that some had to put on their camera to show what gender they were.

- ALT DELEGATE ONLY 2 TYPES OF MEETINGS (OPEN & CLOSED)
- AREA CHAIR WAS PART OF A WOMEN'S MEETING, CLOSED MEETING SPECIAL INTEREST GROUP MAINLY WOMEN WHO WENT ANY ALCOHOLIC WHO SHOWED UP WAS WELCOME
- GSRs participating in BTG program. Having issues with those that were addicts being sent to them. They started getting NA literature out to them. Are other Districts having that issue with BTG?
 - D63 DID NOT HAVE THAT EXPERIENCE WITH BTG. SUGGESTION IS TO GO TO NA MEETING TO SEE IF THERE ARE ANY PEOPLE THERE WHO ARE WILLING TO TAKE PHONE CALLS, SO WE HAVE A CONTACT PERSON.
