Roll Call | Secretary, Lauren B.

- The Secretary conducted roll call. 5 officers were present, and 42 Districts represented, for a total of 47 out of 54 eligible voting members. Please see the roll call tally attached at the end for details.

Acceptance of Minutes from Prior Quarterly Meeting | Chairperson, Tara C.

- Tara verified members read the June draft minutes (sent a month prior and available on Area59aa.org), and if there were any corrections or changes before voting to approve.
- The minutes were unanimously approved, with none opposed.

Convention Committee Report | Convention Chairperson, Pete B.

- 110 Registrations. Encourage your districts and drum up enthusiasm for the convention.

- Past Delegates will be attending District Meetings to talk about EPGSA.
- The link to the room booking defaults to 1 room, 2 guests. Will want to adjust if only needing the room for 1 person.
- We need all the help we can get. It is a lot of fun volunteering. Reach out to Alt Delegate or Secretary if interested in volunteering.

Archivist Presentation | Area Archivist, Donald H. – Area Inventory

- Donald H., Area Archivist, provided a list of the dates of all the Area Inventories held in Area 59. Donald also provided the written invitation provided to EPGSA in 1992, as well as a letter written by the Area Officer at Large that year. July 1992, the Structure Committee voted on not having a DCM workshop but to have an Inventory instead. Discussed that Inventory should be a Sharing Session. Sept 1992 – it was announced that the DCM Workshop would be an Inventory, open to all members. Oct 1992 – 1st Area Inventory. Nov. 1992 – Officers made recommendation to do Area Inventory at the end of each panel. There was no Area Inventory from the period between 1992 – 1999. Delegate at that time mentioned he would like to have an Area Inventory. From 2007 on, there was an inventory in each panel.
- First Area Inventory – went around the room giving each person 2 ½ min to share. First 2 hours would be Area Committee. Last 2 hours would be open to all. Donald has 16 pages of Minutes from that Area Inventory if interested.
- Second Area Inventory – said that the afternoon may allow for all to share.
- Third Area Inventory – Agenda changed. Subcommittees Inventory and then the Area Inventory.
- 2007 Inventory Agenda was similar to the third Inventory.
- Inventory is not always something AA has been fond of. 1963 was the first GSC Area Inventory. There was a Harper's Article that said people could get sober despite AA. Another article said "AA: Cult or Cure?" Wanted to take a good look at how AA was doing. It was done under duress due to the article, and it became quite a topic.

Officer at large, Neill D.

- Had the 1st of 2 Virtual Mini Assemblies for this Panel. Next 1 will be in 2026. Thank you for attending and for your feedback.
- Great to see Districts having great workshops and picnics allowing newcomers to see you can have fun in AA.
- Advisor to Digital Communications Ad Hoc Committee.
- Claire B. was Area 59 Coordinator for Hospitality Suite at the International AA Convention. We partnered with Area 60.
- International AA Convention will be in St. Louis, MO in 2030 and then in Indianapolis, IN in 2035.
- This Monday, GSO rotates to new position.
- EPGSA – Please let Fred know if you need AV Equipment by 10/18. First come, first serve. Please let Fred know what kind of connection you need (HDMI, etc).

Treasurer, Neill D. (OAL on behalf of Jen F.)

- Closed M&T Accounts and has been using the remote deposit scanner, which has been saving time for contributions. Paid expenses and ordered literature and supplies. Connected Districts to secure meeting facilities.
- Was able to get the monthly payment for the Storage unit reduced – saving us approx. \$1,200 a year.

- All Motions need to be submitted to Tara 48 hours before the Pre-Area Officer Meeting. The Meeting is listed in the Service Calendar.
- Tara keeps spreadsheet of which Districts submit Minutes so we can keep track of what is going on.
- Robert's Rule Meeting every first Sunday of the month held Virtually. Next talking about Incidental motions.
- Question:
 - ▣ Can GSRs attend the Roberts Rules meeting?
 - Yes, they can.

Alt Delegate, Alex N.

- Main job is to be aware of what is going on in the conference process and assists the Delegate as needed.
- Meets monthly on Zoom with Alternate Delegates. In July, Northeast Alternate Delegates did a Presentation on how to propose an Agenda Item.
- Intergroup Liaison – Visit all Intergroups and all of SEPIA Zones. Intergroups have incredible success stories and unique conflicts. Looking forward to the Share of Days that are coming up.
- Next year, Alt Delegate will be bringing back the All-Intergroup Day. Will have a Day of Sharing with all of the Intergroups. Will be a central location.
- Went to PENNSCYPAA in Harrisburg, PA as the YPAA Liaison. Was an incredible experience.
- YPAA & Area 59 Share A Day on 9/28 in York, PA. – Will talk about Local, State, and Regional Forums in YPAA.
- NECYPAA has expanded to include all 18 Areas in the Northeast Region.
- GSR Forum will be put on hold for the time being. Some operational concerns and different aspects that need to be considered. Ken T., Northeast Trustee, will be the Speaker in Oct.
- Did a little investigation and found that there were some areas between Area 59 and Area 60 that are not on either map. There are 4 Counties in the middle of our State (Clinton, Fulton, Center, Huntingdon) that are not being represented or may only be partially represented. Do they know about updates version of the Big Book? Are they Informed of AA updates?
- 60 Days away from EPGSA – Desperately need Volunteers!!!
- Questions:
 - What considerations went into pausing the GSR Forum?
 - The Delegate, Dan B., answered that concerns were raised – Typically the job of educating GSRs is the job of the DCMs. This took off way more than we expected. If we were going to offer this as a workshop, we would bring to DCMs to see if this is what the Area needs / wants. If we are doing this forum with only 1 officer, this could be seen as favoritism to 1 officer. Will spend more time researching.

Delegate, Dan B.

- Thanked the Area for his attendance at the International Convention. Volunteered for 5 events at the Convention.
- Final Reports from the GSC will be available online 9/17. Printed copies available shortly after. They will be available at EPGSA. Let Dan know if you want extra paper copies.
- Dan is on the CPC Committee and met 2 times with the Chair, Dawn K. Decided to meet 2 weeks before and 2 weeks after Board weekend to review progress and updates.
- PI Comprehensive Media Plan was discontinued. New Membership survey will be done.
- Deadline: PAI Submissions due 9/30
- Implementation Committee to implement the Inventory done at the GSC.
- Area Inventory – Share with groups in the District. Will also have time for Subcommittees to conduct their Inventory there if they wish before the main Area Inventory.
- EPGSA – Participation is essential!! GSRs should ask their Groups to support their attendance. Get people to Volunteer! ADCMs are expected to be ushers. Thanked the 7 Subcommittees that volunteered to hold workshops. Each Officer & Subcommittee needs to complete a written report. Due in English & Spanish by 10/31. Dan will provide a template. Subcommittee Chairs do not need to submit a Quarterly Report in December unless there are updates.
- EPGSA Draft Program has been provided.

- 2 Questions to bring back to your groups for feedback and will be discussed at EPGSA.
 - ▣ What General Process should we use to classify writings as recovery, service, or archival/historical? Who should determine the classification?
 - ▣ What literature do you consider to be in each category of Recovery, Service, or Archival/Historical?
- General Service Updates –
 - ▣ 2025 2nd Quarter Financial Results: GSB Contributions were 10% less than budget and 17% less the prior year. Operating surplus is \$56k v. budgeted \$221k. GV print subscriptions declined 8% compared to prior year.
- 17 new documents in Google Drive. – PAI status update since August, new versions of “AAWS Highlights” and “About AA Newsletter.” All general communications are in the docs folder.
- NERF 2025 – Hosted by General Service Board – Enhances trust and communication. Will be held in Providence, RI at the Omni Providence Hotel from 12/5 – 12/7. All are encouraged to Attend.
- NERAASA 2026 – 18 Areas gather for this Service Event each year. Will be held in February in Portland, ME. The 2026 Outreach Committee is looking for volunteers.
- Questions:
 - ▣ Tom W., DCM D67 – Will there be a presentation at Assembly for the questions or up to DCMs to get them up to speed?
 - Best to have DCMs get the GSRs up to speed. Dan will send out an email with a few paragraphs about what happened to share with the GSRs to get them up to speed and prepared for the sharing session at EPGSA.

DCM Actions:

- D36 – Has an Officer in the District – Coalition formed that whenever he is doing his agenda, they are telling him how he is supposed to do his job, go to events. The subcommittees in the district have not provided any reports in the last 4 months. Has 78 groups in the District.
 - D66 – Would you mind explaining it a little more?
 - D36 – They were operating under the prudent reserve. Was told in order for him to go to an event, he had to use the cheapest way and not incur tolls. This is a constant problem at the district. Had 22 GSRs and now 11 GSRs. People don't want to go there because of the conflict.
 - D51 – Doesn't have experience with it. Donald did a great presentation on Inventory and that would be a great idea.
 - D26 – She feels his pain but is grateful that she has long timers. They tell her when and where to go. They don't have a lot of funds but they are accepting of the quickest, easiest, and safest way for her to get to where she needs to go. They have 15 groups and maybe 10 GSRs. It is hard to not take it personal.
 - D66 – Had some tension in the district with the previous DCM last panel. He was serving as a GSR and the DCM. District didn't want to pay for him to attend events when he was representing the Homegroup. The relief to that was doing the Inventory at the District. There you can uncover and find unity in these types of things. May find different angles to the issues that they are pointing to.
 - D22 – Doesn't know that the bylaws state for reimbursement but they recently reviewed and revised their bylaws in the district. This clarifies the reimbursement, mileage, and milage rate.

- D48 – Experiencing a lot of growing pains. District doesn't like change and there is a lot of backlash to her following Traditions. Trying to educate everyone of what their roles are. She said she will not apologize for upholding the Traditions.
- D67 – Inventory to be monitored from someone outside of the District.
- D30 – Received recent advice that she can present information as DCM and then there is a discussion. Not to invest in the outcome or be bothered by it. Discussed Robert's Rules. She has to listen to her own conscience of her own duties. Be more open minded. Initially she was not.
- D65 – He is just a trusted servant. They don't have to pay for him to go there, he chooses to go there. The District approves his travel expenses for this year.
- D50 – When she was thrown into the position, the District was dead for many years. Everyone was telling her what to do. The meetings were chaos and she stepped up to the plate. Now meetings are well attended and it got better. If she took toll roads and they didn't want her to, she would eat the cost. District is not wealthy at all. Very hard for them to pay for her to be here in general.
- D66 – Group in the District that is a hybrid group. Looking for experience about using basket money for a laptop. Would use Group Money, not District money.
 - D30 – DCM has provided the laptop for the District meeting. 2 of the Officers had their laptops die. Wants to bring up to GSRs next year for her District on purchasing a laptop for the District.
 - D67 – Talked about this at a previous quarterly. At the Intergroup, 1 person owned the equipment, a vote happened that he didn't like, and he took his equipment and left. If you want to avoid that, the group should own the equipment.
 - D38 – Each group is autonomous. Group decision, not District.
 - D47 – Has luxury of a tech savvy ADCM who donated the equipment. This year, put in a line item in the budget to put away \$200 a year for tech support.
 - D26 – Long timers in District with decades of time donated a screen. 2 members have their personal laptops and they have been hybrid since COVID. So many people from other cities and states come to the meeting. It was a donation. Sometimes internet reception is horrible though.
 - D54 – Some groups do 2 baskets. They can pass a basket specifically for the laptop for members that don't want to contribute to the laptop fund.
 - D30 – The Zoom account has traditionally been covered by a personal account.
- D68 – La Vina is working properly now. Thank you for your support!

- Attended 1 event. Have 2 meetings a month (1 online and 1 in person).
- Provided Outreach Form to be filled out – Gives some suggestions. Purpose of the form is to develop a spreadsheet for better communication between Area & District and hopes it continues into other panels. Do you have a District Archivist?

Out of all the areas, received 2 responses that were No and No. Another member asked an Insurance Agent and the result was they don't offer the policy and most relevant would be General Liability. Information is not privilege information. Also looked into PayPal and that is protected under Paypal's Liability insurance. Don't need to expand liability insurance at this time.
- Looking into having Interpreters and how much it would cost to have a company at Area events so we can provide this service if no one is available. This will be included in the Area Budget at the next quarterly meeting.

- Ordering more window shades.
